STATEMENT

2. Report our arrival to the Directorate of Press and Information Service at the Department of Foreign Affairs in Jakarta, in order to obtain press card(s) and general briefing regarding shooting procedures.
3. Report to the Information Service of the Provincial/Regional Government that will appoint a liaison officer, and bear the expenses related to the services.
4. Carry out the film shooting in accordance with the approved scripts/synopsis as submitted to the Government of the Republic of Indonesia.
5. Refrain from filming sacred rituals, objects or locations forbidden by local beliefs or practices and other restricted areas.
6. Bear all expenses related to entering specific locations and shooting of objects if required.
7. Re-export all the shooting equipments at our expense upon completion of filming and bear all related costs.
8. Submit one released copy of film/video to Government of the Republic of Indonesia through the Embassy of the Republic of Indonesia which may be used at the discretion of the Government of the Republic of Indonesia for non-commercial use.
