IMMIGRATION CHECKPOINTS (TPI), REQUIREMENTS, AND
PURPOSE OF VISIT FOR FOREIGNERS WITH VISIT VISA
EXEMPTION

WITH THE GRACE OF GOD ALMIGHTY,
THE MINISTER OF AND LAW HUMAN RIGHTS,

- Considering : that for the purpose of implementing the stipulations within Article 5 of Presidential Regulation No. 21 Year 2016 on Visit Visa Exemption, it has become necessary to establish a Minister of Law and Human Rights Regulation on Immigration Checkpoints,

HAS DECIDED TO:

Establish : MINISTER OF LAW AND HUMAN RIGHTS REGULATION ON IMMIGRATION CHECKPOINTS (TPI), REQUIREMENTS, AND PURPOSE OF VISIT FOR FOREIGNERS WITH VISA EXEMPTION

Article 1

The following terms in this Minister Regulation can be taken to mean as follows:

1. Immigration Checkpoint (*Tempat Pemeriksaan Imigrasi*), from herewith abbreviated as TPI, consists of checkpoints in seaports, airports, cross-border posts, or other locations serving as entry and exit points to and from the Republic of Indonesia.
2. Republic of Indonesia Visa, herewith referred to as Visa, is a written statement issued by the proper authority under a Representative Office of the Republic of Indonesia or another office as established by the Government of Indonesia, containing approval for a Foreigner to undertake a visit to the Indonesian Territory and serves as the basis for issuing a stay permit.
3. Foreigners are persons who are not citizens of Indonesia.
4. Republic of Indonesia Territory, herewith referred to as Indonesian Territory, consists of all Territories in Indonesia and certain zones as established within Law No. 6 Year 2011 on Immigration.

Article 2

Foreigners from certain countries, special administrative local governments of certain countries, and certain entities exempted from the obligation to have a Visa to enter Indonesian Territory must fulfill the following requirements:

- a. carry the original copy of a valid passport which would be in effect for at least 6 (six) months;
- b. carry a return ticket or onward ticket to another country; and
- c. never have been blacklisted.

Article 3

Foreigners exempted from the obligation to have a visit Visa as stipulated in Article 2 may conduct activities for the following purposes:

- a. tourism purposes;
- b. family purposes;
- c. social purposes;
- d. art and culture purposes;
- e. government assignments;
- f. giving speeches or attending seminars;
- g. attending international exhibitions;
- h. attending meetings held with a central or representative office in Indonesia; and
- i. continuing travel to another country.

Article 4

The list of TPI as entry and exit points to and from Indonesian Territory for Foreigners as stipulated in Article 2 can be found in the Appendix as an inseparable part of this Minister Regulation.

Article 6

This Minister Regulation shall be in effect from the date of its promulgation.

In order for this to be known to all, the order is given to promulgate this Law by insertion in the Republic of Indonesia State Gazette.
